If fail to do so Gibson Soak Water shall be entitled to recover any or all of the following agreed reasonable default charges, as a Charge in addition to the price and other charges:

- Interest, which shall compound monthly from the due date at the rate of 15% per month on total overdue account balance.
- All Administration costs or charges for any accounts or Tax Invoices that remains outstanding after the due date.
- All costs of debt collection services retained to recover overdue unpaid monies.

Gibson Soak Water Co shall further be entitled to claim as a charge the cost of all legal costs incurred by Gibson Soak Water Co on a 'solicitor own client' basis for any work associated with or resulting from a default or collection of overdue payment. In event of a default by the customer Gibson Soak Water Co shall be entitled to cease all existing credit accounts, stop any further delivery and refuse any further orders as modified by these Terms and condition of Trade.

Buyer assumes full responsibility for all goods purchased from Gibson Soak Water Co.

Unless otherwise quoted by Gibson Soak Water Co. the Buyer is responsible for payment of all deliveries of goods to their delivery address.

Bottle deposits are refunded on the condition that the bottles are returned clean and not damaged. Bottles are sometimes reused by the Buyer for other liquids such as petrol and diesel, oils and other miscellaneous chemicals. You will forfeit your deposit on any empty bottles that are found to be contaminated as they are not reusable.
