



You have purchased a quality product from Reece Pty Ltd ABN 84 004 097 090 ("Reece"). This product is covered by a 10 year heat exchanger warranty and 3 years warranty over parts and labour.

#### 10 YEAR HEAT EXCHANGER WARRANTY

This warranty covers faults in the product construction, material and assembly. Heat exchangers which are within 10 years of the date of purchase, found upon inspection by an authorised Reece representative, to be defective in construction, material or assembly, will be repaired or exchanged with an equivalent product free of charge. Replaced items become Reece's property.

All replacement products will be available for collection without charge to the customer at the nearest Reece branch to the customer's location, or elsewhere as agreed between the customer and Reece.

#### **Labour and Spare Parts**

The labour for the replacement of products and spare parts to which this warranty applies will be supplied by Reece or relevant supplier using licensed plumbers engaged by Reece or relevant supplier within 3 years from the date of purchase.

Spare parts which are within 3 years from the date of purchase found upon inspection by an authorised Reece representative to be defective in construction, material or assembly, will be replaced free of charge.

# **Warranty Conditions**
